At -1.21%, wholesale inflation in Oct lowest in 27 months

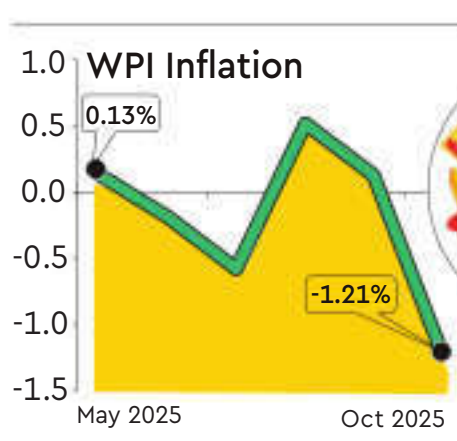

INDIA'S WHOLESALE PRICE inflation re-entered the negative territory in October primarily due to decline in prices of food articles, crude petroleum & natural gas, electricity, mineral oils, and basic metals, data released by the government on Friday showed.

The Wholesale Price Index (WPI) inflation fell to a 27-month low of (-)1.21% in October from 2.75% in the same month last year. It was (-)1.2% in July 2023.

This also marked the third instance of WPI inflation being in the negative zone in the last six months. It was (-)0.19 and (-)0.58 in June and July, respec-

tively. According to the data, the deflation in food articles was 8.31% compared to 5.22% in September with the prices of vegetables, onions and fruits declining in October.

The food index (24.38% weight in the index) consisting of 'food articles' from primary

articles group and 'food product' from manufactured products group has remained constant from September to October.

The rate of inflation based on WPI food index decreased to (-) 5.04% in October from (-) 1.99% in September.

Retail inflation plunged to a

series-low of 0.25% in October, due to a favourable base effect, drop in the prices of vegetables, cereals, fruits, and the impact of decline in the Goods and Services Tax (GST), according to data released by the National Statistics Office (NSO) on Wednesday. The decline in both retail and WPI inflation rates increasing the chances of rate cut in December.

The Reserve Bank of India had kept the policy rate unchanged at 5.5% in October.

Government data showed the primary articles inflation was (-)6.18% during the month as compared to -3.32% in September. Fuel power inflation in October was (-)2.55% as compared to (-)2.58% in the previous month.

Oil India Q2 net profit declines 21%

STATE-RUN OIL India on Friday reported a decline of 21% in its consolidated net profit for the second quarter of fiscal year 2025-26 at ₹1,643.81 crore against ₹2,069.16 crore in the same period last fiscal.

The company's revenue from operations for the quarter under review stood at ₹9,175.41 crore, up 12.7% from Q2FY25.

Total income too increased by 9% from last year to ₹9,692.58 crore. The company achieved a standalone profit after tax of ₹1,044 crore in Q2FY26 against ₹1,834 crore achieved in Q2FY25 due to sharp drop in crude price realisation from \$79.33/bbl in Q2FY25 to \$68.19/bbl in Q2FY26, a drop of 14%.

The board has recommended an interim dividend of ₹3.50 per fully paid equity share.

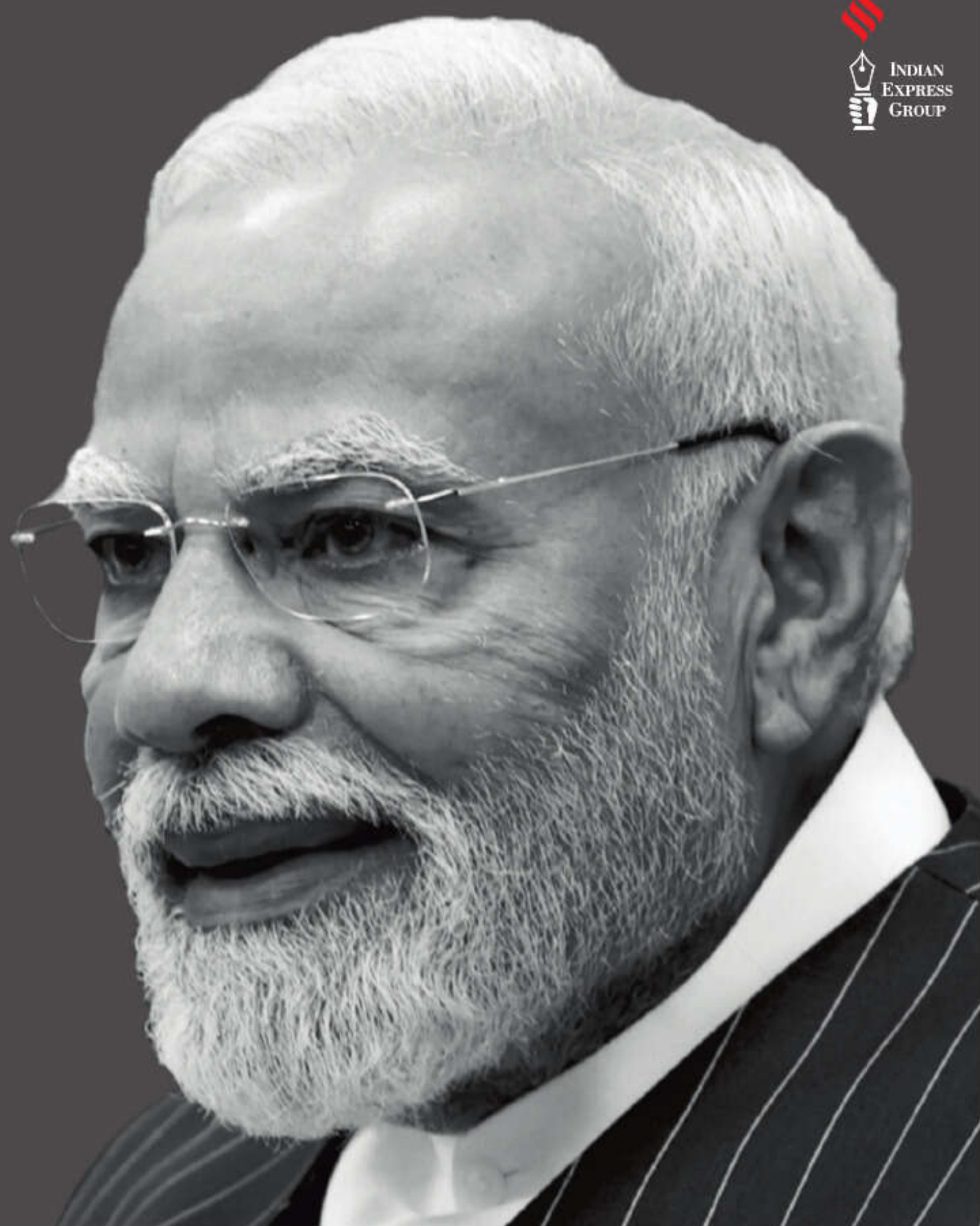

बेघरों को आश्रय देने के लिए शीतकालीन कार्य योजना पर काम शुरू

नई दिल्ली, 14 नवंबर।

दिल्ली शहरी आश्रय सुधार बोर्ड (डूसिब) ने बेघर लोगों को आश्रय देने के लिए शीतकालीन कार्ययोजना शुरू कर दी है। इस अभियान के तहत, बेघरों को गर्म बिस्तर, चादरें, गर्म पानी और शौचालय, पीने का पानी, लॉकर और बिजली जैसी बुनियादी सुविधाएं उपलब्ध कराई जाएंगी। दिल्ली शहरी आश्रय सुधार बोर्ड (डूसिब) ने कहा कि वह वर्तमान में शहर भर में 197 आश्रय गृहों का संचालन कर रहा है जिनमें 82 स्थायी भवन और 115 अस्थायी संरचनाएं शामिल हैं।

डूसिब ने कहा कि 15 नवंबर से बेघर लोगों की बड़ी संख्या वाले स्थानों पर 'पगोडा' शैली के लगभग 200-250 तंबू लगाए जाएंगे, जिससे बिस्तरों की संख्या में 2,000 से 2,500 तक की वृद्धि होगी। इसने कहा कि ये अस्थायी आश्रय स्थल 15 मार्च तक संचालित रहेंगे। अधिकारियों के अनुसार, खुले में सोने वाले लोगों को सुरक्षित स्थानों पर पहुंचाने के लिए डूसिब रोज रात 10 बजे से सुबह चार बजे के बीच 15 बचाव टीम तैनात करेगा। अधिकारियों के अनुसार, 'रेन बसेराएफ' को शुरू कर दिया गया है। इस एफ के माध्यम से कोई भी नागरिक, जरूरतमंद बेघर व्यक्ति की तस्वीर अपलोड कर सकता है। डूसिब ने बताया कि यह एफ बचाव दलों को सतर्क करने और दर्ज की गई शिकायतों की स्थिति पर नजर रखने के लिए 'जीपीएस लोकेशन' का उपयोग करता है। रेन बसेरा में रहने वाले लोगों को उपलब्धता के अनुसार बिस्तर और कंबल आबंटित किए जाते हैं।
